

## PUBLIC NOTICE

The County of Armstrong OBO East Franklin Township, Kiskiminetas Township and Manor Township has designated portions of each municipalities Community Development Block Grant (CDBG) funds received from the Pennsylvania Department of Community and Economic Development Program for multi-year housing rehabilitation funding. The CDBG Program provides housing rehabilitation assistance to low-moderate income, owner-occupied households located within East Franklin Township, Kiskiminetas Township and Manor Township. Eligible applicants can receive a deferred grant to correct the code deficiencies at their residence. Additionally, lead safe work practices and "short term" radon measures are required. To be eligible for participation in this program, applicants must be a resident of East Franklin Township, Kiskiminetas Township or Manor Township. The applicant must own and occupy their home, and meet income guidelines. Other restrictions, rules, regulations, and guidelines pertain to this program.
