East Franklin Township Sewage Report January 2020 Report by David Stewart

A pump was repaired at the Boltz Pump Station.

The Sewage Truck was inspected and four new tires were put on the truck.

I attended an "Asset Management" class on January 15th at the Ford Cliff Volunteer Fire Hall. This class enabled me to obtain 4 wastewater training credits.

Fourteen out of the fifteen required wastewater training credits have been completed. Fifteen credits have to be completed between the dates of July 1, 2019 through June 30, 2022.

All required lab samples for January were collected and transported to CWM. All DMR reports for the month of December 2019 were submitted to DEP.

East Franklin Township Sewage Report February 2020 Report by David Stewart

The DEP Sewage Compliance Inspection was done on February 11, 2020 for the Adrian Sewage Treatment Plant. The Plant is in compliance in all parameters. There were no non-compliances found.

To save on shipping costs, we purchased all the chlorine and soda ash that we need for the entire 2020 year.

Shut-Off Water Notices were posted on the applicable houses.

All required lab samples for February were collected and transported to CWM. All DMR reports for the month of January 2020 were submitted to DEP.

East Franklin Township Sewage Report March-May 2020 Report by David Stewart

Concerning the Coronavirus, we decided to follow the lead of the PUC's emergency order prohibiting utilities to terminate services. We will not be issuing water shutoff notices to our customers because of unpaid sewage bills. When the Emergency order is lifted, however, we will require payment of delinquent sewage charges.

On March 6, 2020, two loads of sludge were hauled from the Fox Hollow STP and on April 3, 2020, two loads of sludge were hauled from the Adrian STP. The sludge was hauled by Atkinson's and taken to the Worthington Sewage Plant.

A DEP Sewage Inspection was done on May 11, 2020 for the Fox Hollow Sewage Treatment Plant. The Plant is in total compliance.

All required lab samples for March and April were collected and transported to CWM. All DMR reports for the months of February, March and April 2020 were submitted to DEP.

East Franklin Township Sewage Report May 2020 Report by David Stewart

A DEP Sewage Inspection was done on May 18, 2020 for the Tarrtown Sewage Treatment Plant. The Plant is in total compliance.

A DEP Sewage Inspection was done on May 26, 2020 for the Cowansville Sewage Treatment Plant. The Plant is in total compliance.

All required lab samples for May were collected and transported to CWM.

East Franklin Township Sewage Report June 2020 Report by David Stewart

A real estate transfer inspection was done in Tarrtown.

Repairs were made to the Boltz Pump Station and the Fox Hollow Treatment Plant.

All required lab samples for June were collected and transported to CWM. All DMR reports for the month of May 2020 were submitted to DEP.

East Franklin Township Sewage Report July 2020 Report by David Stewart

A real estate transfer inspection was done in Tarrtown.

On July 22, 2020, two and a half loads of sludge were hauled from the Tarrtown Sewage Plant and half a load of sludge was hauled from the Adrian Treatment Plant. The sludge was hauled by Atkinson's and taken to the Worthington Sewage Plant.

All required lab samples for July were collected and transported to CWM. All DMR reports for the month of June 2020 were submitted to DEP.

East Franklin Township Sewage Report August 2020 Report by David Stewart

On July 31, 2020, sewage service was discontinued at 105 Pence Road, Cowansville, PA, 16218 and on August 11, 2020, sewage service was discontinued at 126 Waterway Drive, Adrian, PA 16210.

All required lab samples for August were collected and transported to CWM. Two additional lab samples were done at each plant, per DEP yearly requirements. All DMR reports for the month of July 2020 were submitted to DEP.

East Franklin Township Sewage Report September 2020 Report by David Stewart

Three real estate transfer inspections were done in the month of September; one in Adrian, one in Cowansville and one in Fox Hollow.

There were two one-calls this month.

General maintenance was performed at all Plants and Pump Stations to prepare for the winter season. Air Filters were replaced, and oil was changed. A new pump was purchased for the Boltz Pump Station.

The flow meters at all four Sewage Treatment Plants were calibrated. We will receive a certification for each plant. DEP requires that all flow meters be calibrated on a yearly basis.

To save on shipping costs, we purchased all the chlorine that we need for one year.

All required lab samples for September were collected and transported to CWM. DMR reports for the month of August 2020 were submitted to DEP.

East Franklin Township Sewage Report October 2020 Report by David Stewart

The Sewage Department's Emergency Response Plan was reviewed and updated.

A sewage inspection of sewage lines and man holes was done for PennTex Ventures at 105 Pence Road, Cowansville.

All Generators were checked for operations and repaired accordingly. We had mice that chewed through wires in the Generators at Adrian and Cowansville Plants.

The Grinder was rebuilt at the Adrian STP (Claypool residence).

There were three one-calls; two at Cowansville and one at Fox Hollow.

All required lab samples for October were collected and transported to CWM. All DMR reports for the month of September 2020 were submitted to DEP.
