Planning Commission met Jan. 25 and reviewed the above permits. The Commission also reviewed two property subdivisions:

Reed – Harvest Plan, involving John & Beverly Reed, 151 Reed Road, and Harvest Community Church, 143 Reed Road. Three parcels totaling app. 12 acres will be adjoined to the Church property. One Lot of 1.7 acres will be adjoined to the Montgomery Trust and a small piece of property will be adjoined to the Michael & Amy Mills parcel.

Shearer Plan #1, Presley & Michele Shearer, 310 Lemmon Hollow Road, seek to subdivide a separate lot of 2.0 acres leaving 2.54 acres remaining.

On December 8, 2020, a new commercial sewage customer, Dollar General, was added in the Cowansville area.
