On March 25th, the Chapter 94 Reports for all four sewage plants were submitted to DEP.

On March 29th, a new residential sewage customer was added in the Cowansville area.

On April 23rd, two loads of sludge were removed from the Adrian Sewage Treatment Plant and the sludge was hauled by CWM; and on this same date, the Boltz Pump Station was jet washed by CWM.

Two pumps were rebuilt for the Boltz Pump Station.

Two belts were replaced at the Adrian Sewage Treatment Plant.

There were three one-calls this month.

All required lab samples for April were collected and transported to CWM. DMR reports for the month of March 2020 were submitted to DEP.
