# EAST FRANKLIN TOWNSHIP GLADE RUN ROAD KEY PERSON VIRTUAL MEETING

A Speed Study was done with 85% of the cars traveling 64 mph in one direction and 68 mph in the other direction. It was noted that the State Police patrol both US 422 and Glade Run Roads.

On Thursday, October 27, 2022, there will be a "Field Day" at the Glade Run Road intersection. At the Field Day, Sight Distance is one of the things that will be checked.

Traffic Signals will be evaluated.

An Intersection Control Evaluation will be done to decide what is the best option for the intersection.

Alternatives to Traffic Signals are a U-turn, Signage and possibly eliminating the intersection.

The Supervisors spoke about the many residents that have been upset for years regarding the accidents and even deaths that have occurred at this intersection. Our objective is to make our residents feel protected and to listen when they have concerns such as this.

The Glade Run Road intersection onto Butler Road was also discussed. The Supervisors commented on the fact that trucks are always getting stuck when trying to go onto Butler Road. Penn Dot will be contacted regarding updating the GPS in our area.

Another virtual meeting with Key Personnel will be held within a couple weeks. At this meeting, the Supervisors can give more suggestions and feedback regarding the intersection.

# Road Report for October 2022

This month began with fall clean-up. We took in 5 dumpsters full of garbage, 1 dumpster full of scrap metal, and 4 pallets full of televisions. The TVs were hauled to a recycle center in Greensburg. Heritage Park was closed for the season. The restrooms were winterized and closed. Several dirt roads were graded and the ditches cleaned. Potholes were patched. The lines on Wible Rd. were repainted. Our mowers were serviced. Salt and ashes were delivered and stockpiled. We got 1 truck equipped for winter. We had 1 callout for a stop sign down on Wible Rd. The new bridge on Lemmon Hollow Rd. is nearly done. The road is expected to reopen soon.

The Fox Hollow Sewage Line Extension Project is on schedule.

The Sewage Department's Emergency Response Plan was reviewed and updated.

The flow meters at all four Sewage Treatment Plants were calibrated. We will receive a certification for each plant. DEP requires that all flow meters be calibrated on a yearly basis.

There was a one-call in Cowansville.

Lab samples were collected for the month of October and transported to CWM. DMR reports for the month of September 2022 were submitted to DEP.
