(Amending Section 9. Expiration of Document of Certification: A Document of Certification Issued under this Ordinance shall be valid for a period of 7 years from the date of issuance). (Currently 3 years). Motion approved unanimously.

Motion made by David Stewart and seconded by Dan Goldinger to authorize to advertise ordinance establishing and implementing a program to charge user fees for the deployment of public safety services rendered by the West Hills Emergency Services. Motion approved unanimously.
