Introduction

The OOR E-File Appeal Portal (“E-File Portal”) is an online docketing records management system designed to streamline and automate the appeals process. Appeals filed and all submissions to the Office of Open Records (“OOR”) are accessible in real time and allow the requester, the agency, and OOR Appeals Officers to file, receive, and have access to documents and submissions.

The E-File Portal is being released in two phases. Phase 1, testing, Phase 2, random E-File Portal appeal assignment and Phase 3, full roll-out.


During Phase 1, once an appeal had been determined to be eligible for E-File Portal access, the OOR will send a consent form to the agency and the requester. If both parties agree to use the E-File Portal, they will sign the consent form and return it to the OOR. Both parties will receive an email of their login and password to access the E-File Portal via <https://www.openrecords.pa.gov/portal/login.cfm>. If the parties do not agree to use the E-File Portal, the appeal will proceed through the current appeal process utilizing email, fax, mail, and UPS/FedEx.

During Phase 2, appeals will be chosen randomly, at set intervals, for assignment to the E-File Portal. Access will be granted following receipt of the appeal once an OOR Appeals Officer has been assigned. Parties will be notified that the appeal was chosen for processing through the E-File Portal.

During Phase 3, all appeals will be conducted through the E-File Portal. Access will be granted following receipt of the appeal once an OOR Appeals Officer has been assigned. New users will receive their login credentials. Current users will receive an email to check the E-File Portal for new documents.


Accessing the Appeal E-File Portal

1. The parties will receive an email once they are granted access to the E-File Portal. Access is granted by the party's email addresses. For agencies, this will be the Agency Open Records Officer's email address.




2. The E-File Portal can be accessed through the web link contained in the email notification, or <https://www.openrecords.pa.gov/portal/login.cfm>. The page can only be accessed by a party in an appeal.

In Phases 2 and 3, if the appeal is chosen as an E-File Portal appeal, parties will also be able to access the Portal through a thumbnail on the OOR's website as shown below.



3. Log in to the E-File Portal by entering your Email and Password. If a party has forgotten their password, they may reset it on this screen.

If a party has not received an email with login credentials and the email was not found in a spam folder, use the Reset Password.

Using the Appeal E-File Portal

E-File Appeal Portal – My Appeals

Upon logging in to the E-File Portal, all appeals that a party has before the OOR will be listed.

Click on the line containing the appeal details to view more details, make a submission, or review files added by other parties, submit an Entry of Appearance, and request Direct Interest Participant Access.
