### East Franklin Township Sewage Report July 2023 Report by David Stewart

On November 19, I attended a PENNVEST Board meeting in Harrisburg.

The NPDES Renewal Permit for the Fox Hollow STP was submitted to DEP.

The final NPDES Permit for the <u>Tarrtown STP</u> was received. This permit will become effective on August 1, 2023 and will expire at midnight on July 31, 2028. Additional lab tests are now required for E. Coli, Nickel, Zinc and Chloride. CWM was notified of these modifications and changes were implemented on the monthly DMR.

There were two one-calls this month; one at Reesedale and one at Tarrtown.

Lab samples were collected for the month of July and DMR reports for the month of June 2023 were submitted to DEP.
