East Franklin Township Sewage Report September 2023 Report by David Stewart

A real estate transfer inspection was done in Tarrtown.

On September 14th, sludge was hauled from the Cowansville STP by CWM.

The Sewage Department's Emergency Response Plan was reviewed and updated.

The flow meters at all four Sewage Treatment Plants were calibrated. We will receive a certification for each plant. DEP requires that all flow meters be calibrated on a yearly basis.

The hydraulic pump in the digester tank was repaired at the Cowansville STP and a blower was repaired at the Tarrtown STP.

Lab samples were collected for the month of September and DMR reports for the month of August 2023 were submitted to DEP.
